

Recommendations of The Grievance Redressal Committee

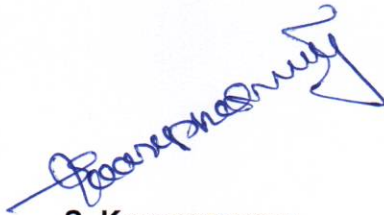
The grievance redressal committee (GRC) consisting of the following members
